## Heronswood Presents at Pacific Northwest Plant Event

In mid-June, Heronswood Garden Director Ross Bayton and Debby Purser, staff gardener and volunteer coordinator, presented to the Hardy Plant Study Weekend, an annual event that brings together gardeners from all over the Pacific Northwest for a series of lectures, garden tours, and social events. This year it was hosted by the Northwest Perennial Alliance in Bellevue.

Bayton and Purser gave a lecture entitled “Heronswood: Connecting Plants, People, & Places” to an audience of around 400 attendees. While Bayton is used to public presentations, this was Purser’s first time speaking to a crowd this size. There were some initial nerves, but she worked through them and did great, sharing with attendees the work she has done creating Heronswood’s S’Klallam Connections Garden.

Their presentation was very well received and left people inspired by the Tribe’s commitment to Heronswood and enthused to come visit the Garden soon!

# TRIBAL ELECTIONS: JULY 11

## **Tribal Elections**

The regular elections for members of the Port Gamble S'Klallam Tribal Council will be held on Monday, July 11<sup>th</sup>, 2022 at the Tribal Center. Polls for voting will be open from 8:00 A.M. to 7:00 P.M. on the day of election. The positions on the ballot this year are: Vice-Chairman, Councilman I, and Councilman IV.

Those running for these positions are:

Vice-Chairman: Chris Tom

Councilman I: Renee Veregge, Bethany Swift

Councilman IV: Amber Caldera, Walter Jacobsen

## **Eligible Voters**

Only members who are over the age of eighteen (18) on the day of elections and who have registered to vote shall be eligible to vote in tribal elections.

Any person who appears at a polling place to vote and who is not personally known as a member of the Port Gamble S'Klallam Tribe to the Election Committee members present must show acceptable identification and proof of membership in the Port Gamble S'Klallam Tribe before he or she may be given a ballot.

## **Registration of Voters**

The following requirements shall apply to the registration of voters:

1. In order to vote in a particular election, a voter must first register to vote. A person may register to vote at any time, including Election Day, prior to the time he or she votes. Once a person has registered, he or she may keep the registration valid and current by voting once each year.
2. Registration shall be accomplished by completing a registration card and filing it with the Election Committee.

## **Absentee Voters**

All persons wishing to vote by absentee ballot shall notify the Election Committee of the request no later than one (1) week prior to an election day. The Election Committee may not accept absentee ballot requests that are submitted less than one (1) week before an election day. Absentee ballots shall be requested personally by the voter; no requests for absentee ballots shall be honored from relatives or others purporting to act on behalf of the voter.

Persons voting by absentee ballot shall deliver their ballots to the Election Committee no later than 7:00 P.M. on Election Day or mail their ballots to the Election Committee. If the ballot is mailed, it must be received by 7:00 P.M. on Election Day.

To request an absentee ballot, please call Jordan DeCoteau at 360-297-6217. Normal office hours are Monday-Friday 8:00-4:30. Feel free to leave a message and include a call back number. You may also call the Tribal Center front desk at 360-297-2646 and you will be transferred.



## Tribal Council Elections: Candidate Letters

Below please find letters from the candidates running for Councilperson I. The letters appear as they were submitted with the incumbent candidate's entry coming first.

### Renee Veregge

#### *Incumbent, Councilperson I*

Hello, my name is Renee Veregge, my parents are Jeffrey and Connie Veregge, and my grandparents are Frank and Cyrene Sullivan and Will and Betty Norris. I have two beautiful children, Jaxon and Whitley, whom are my pride and joy. This is my Letter of Intent for Council Position I.

I currently hold Tribal Council I and am seeking re-election on the July 11, 2022, PGST Council Elections. I have been honored and humbled to serve in this position for the past 8 years and feel I have done the best job to my ability to advocate and fight on behalf of our Tribal Membership and community.

I have earned an Associates degree with Highest of Honors from Northwest Indian College and a Bachelor of Science in Accounting degree from City University of Seattle, of which I am very proud. I have worked for the Port Gamble S'Klallam Tribe since 2004. I started out as the Dental Receptionist, Medical Biller, worked as the Finance Manager for the Port Gamble Housing Authority, and, for the past 8 years as the Special Projects Director. I enjoy working for my tribe and trying to find new ways to serve and meet the needs of our tribal membership.

I am a huge supporter of all educational avenues and will encourage anyone to invest in themselves by gaining an education of their choice. I would love to see PGST fully fund all higher education costs in its entirety. This would help alleviate financial burdens to our people and may incentivize them to obtain the highest education they seek but may not pursue due to the out-of-pocket expense. This is a goal I will work towards achieving, if re-elected. I believe knowledge is power, and it is one thing no one can take away from you. I believe that gaining an education is an investment in yourself, but also, an investment in our Tribe. I would love to see all lead positions in the Tribe, be held by tribal members. Providing financial assistance to our people, could make this dream a reality

In my first Letter of Intent to run for Tribal Council, I stated how I wanted to be a voice for Our People, and I still stand by that. I am always willing to listen to our tribal members when they approach me with suggestions, questions, or concerns. I will

answer them on the spot if I have the answer and if I don't, I will go to the appropriate staff or department to find it and let the tribal member know what I found. When I receive complaints or suggestions, I will present them to the rest of the Council during the "Open Comments" portion of the Tribal Council meetings, often at the resistance from staff, but I will continue to do this, as I believe a closed mouth doesn't get fed.

During my time on Tribal Council, I have had the opportunity to approve new programs/services, enhancement of existing programs/services that positively impact the lives of our Tribal Members. Some of the programs, codes, businesses, and direct services I have fiercely and strongly advocated for, and we approved are:

- Annual school clothes vouchers for our K-12 students
- Increase in funding for our youth extra-curricular activities
- Utility "cash" payments to our elders, allowing them to apply the funds as they best see fit and am currently advocating with other councilmen to increase this amount.
- Covid assistance to our tribal members December 2021, Cash distribution of \$5,000 to tribal members 18 years and older
- Boards/Committees to be re-evaluated and assessed to ensure the stipends matched their duties/roles by an outside source, which resulted in an increase for all boards and committees
- Legalization of Marijuana
- High Point cannabis retail store as another revenue stream for the Tribe
- Distribution of generators and extension cords to our elders
- Completely removing Fish Tax for our fishermen
- Development of the Community Garden

I believe in providing our tribal members with the opportunity to decide how to best spend funds for their own families. I don't like the idea of "counting other people's money" and I certainly will not dictate how those funds would be best used for all families, only my own. This is something I will always fight for on behalf of our people. *(cont on bottom of next page)*

## Bethany Swift

### *Nominee, Councilperson I*

S'Klallam Family,

Hello, my name is Bethany Swift. I am the Daughter of Francine Swift and William Swift Sr., the Granddaughter of the late Gerald Jacob "Jake" Jones, and June "Tiny" Jones. I am putting my letter of intent to run for your Council Position I.

I have my Bachelors Degree in Native Studies Leadership and graduated with high honors from Northwest Indian College. I am hoping to further my Education with my Master's Degree in Native Leadership.

I am the Mother of 5 children, Isaiah Pondelick, Harmony Tyson, Lillian Pondelick, Charity Tyson and Lenaya Pondelick. I am the Fiancee to Raymond Pondelick. I am also employed with our Tribe within the Career and Education Department for the last 11 years. I am holding the position as the Academic Coach Coordinator.

I am new to learning policy and guidelines that our Tribe has put in place. I would love to learn the extent of the laws and guidelines that our Tribe continues to put in place. I believe that we have a smooth system here for our people. There are some laws that I believe can be amended without too much punishment of our people. Growing up, we as Royalty were responsible for having good grades in school, attending gatherings, answering to council and if in trouble, answering to council and our Elders. I would love to see these things be put in to place again as it is a part of our culture and teaches our young ones how important it is to carry yourself in a good way, as we are a part of the image of our people.

I believe that treatment is a beautiful thing for those addicted. I feel like we could even create our own treatment facility

as we grow our Welcome Home Program. I also feel like some of the laws for those who commit serious crimes, should abide by stricter punishment, such as taking rights away for a year or two as well as getting help away from home. I believe we could create a system where we offer help to those ones by "tough love".

I love our Culture. I have been a part of the Canoe family since 1989 at the age of 3, as the Kloomachin was being created. I have done my capstone on carrying on our arts and culture for my Bachelors Degree.

I have been involved heavily in the Education system with the North Kitsap School District and would love to see that partnership continue to grow. My dream however is to see us have our own Education system here on our beautiful reservation. I would love to see more of our students feel happy and comfortable by learning by their means. I have been so proud seeing our young ones and adults alike, gaining their diplomas, degrees, and trading school certificates. I believe each tribe Member has a gift, and I would love to see them utilize it in the way they learn to their capacity.

I am ready to learn and grow within our community and make an impact on those around me. If chosen, I will carry myself in a good way and show others that we are The Strong People. I will let my voice be heard and listen to the community members alike. I feel like this is where we can gain more ideas and come together to make our community a greater place.

Thank you all for your consideration, and taking the time to read my letter of intent.

### *Renee Veregge Letter (con't.)*

During the Covid-19 pandemic, we were faced with making numerous decisions, not only for our tribal membership but also for the tribal government. Every decision I made was based on scientific evidence, advice from our medical providers of whom we have Dr. Scott Lindquist, WA States Epidemiologist, and recommendations from the CDC to keep everyone as safe as possible and to prevent 1 death from Covid in our tribe and community. We made some hard decisions, but I did and still stand by each one. When we received the second round of funding during the pandemic, I advocated and fought on behalf of our tribal members, to get direct benefits out to our people as soon as possible and with the largest distribution at once, it took longer than I wanted, but was able to achieve that with support from other Council members and the hard work from our staff.

As many of you are aware, this past year has been a very difficult time for my family. Having and watching someone I love to go through severe health issues has made me look at life differently and appreciate the little things more. I love my family and I love that we are all part of the Port Gamble S'Klallam Tribe, because Our Tribe and Our Community all pull together to support one another through the hard times. Our community has been so loving, generous, kind and caring to my family during this year and I will be forever grateful for that. My hands go up to you all.

Thank you all for taking the time to read my Letter of Intent, if re-elected I will remain the Strong S'Klallam woman that I am and will continue to be a voice for our people, fight for the rights of our people, and advocate for the best programs, policies and services that best serve the needs of our people and community.

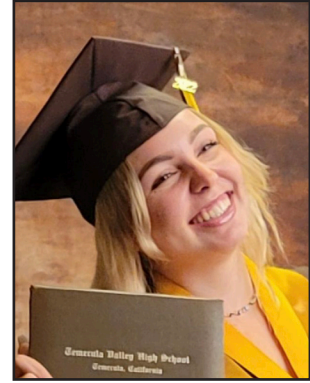
