

## PGST Child Welfare Program Recognized by Harvard Kennedy School

The Port Gamble S'Klallam Child Welfare Program is one of nine tribal governance programs that has been selected by the Harvard Kennedy School Project on Indigenous Governance and Development's Honoring Nations program as a 2023 All-Star. Since 1999, the Honoring Nations program identifies, celebrates, and shares excellence in American Indian tribal governance.

The 2023 All-Stars were chosen from 142 Honoring Nations awardees. At the heart of Honoring Nations is the principle that tribes themselves hold the key to generating social, political, cultural, and economic prosperity and that self-governance plays a crucial role in building and sustaining strong, healthy Indian nations.

PGST's Child Welfare program investigates child abuse and neglect, while working, as appropriate, to reunite children and families in care, including resolving safety and risk issues. The program also provides Family Support Services, including in-home services; family and individual therapy; family meetings, and parent skills support. Staff advocate for PGST children in state courts across the United States.

PGST's Child Welfare Program is managed by Joylina Gonzalez under the direction of Cheryl Miller, Director of Child & Family Services.

In a letter announcing the recognition of the Child Welfare Program, Honoring Nations program manager, Megan Minoka Hill, wrote, "Your leadership to exercise tribal sovereignty and strengthen S'Klallam families by integrating S'Klallam core values into child welfare services is exceptional and holds lessons for tribal nations across Indian Country. The Board was particularly impressed by the proactive provision of resources and comprehensive care offered to families so that children remain in their homes. We are certain that you and your team will benefit your Nation for many generations to come."

Tribal Council Elections are on July 10 in the Main Tribal Center Admin Offices.

There are three positions up for election, including Chairman (currently held by Jeromy Sullivan), Council I (currently held by Donovan Ashworth), and Council III (currently held by Matthew Ives). All incumbents are running for re-election.

Jonelle Grady is also running for Council III. Her Letter of Intent appears below. Currently, Jonelle is the only person, other than the incumbents, running for elections. If others state their Intent to Run before the June 9 deadline, they will be included in a listing of all the candidates in the July edition prior to the election.

## Checking in with the Cougars: An Update from the Cougar Project





He was about 18 months old, and still traveling with his sister after the two of them were kicked off their mom's territory. He weighed 128 pounds. Since we collared him, he has traveled over 1165 miles.

We think he is establishing his own home range near south of Port Angeles and near the Elwha River. Once he establishes his own home range, he will not leave that home range for the rest of his life.

On the map the light-colored dots are older locations, and the darker dots are more recent. Cougars do not travel this far except once in their life. Bjorn was dispersing, which is when sub-adults leave home and travel a far distance looking for a place to establish their own territory. Males tend to travel farther during dispersal than females. Traveling a long distance helps to mix genetics with other cougars who are not related but because the Olympic Peninsula is surrounded by water on so many sides, Bjorn walked a very long way to establish a home range relatively close to where he was born.

The map to the right shows his travel route. He left the Quilcene area in July 2022, traveled up to Port Townsend, then followed the coastline west almost to Sekiu before turning inland and traveling to the Pacific Ocean near Lake Ozette. He rested a short while, then went north to Neah Bay, then back-tracked south still following the coastline to the Quinault Reservation. From there he turned inland and crossed all Olympic National Park in mid-October through early November ending just south of Port Angeles.

## 2023 Elders Trip Reservations Open

The Elders will be going to Las Vegas for the 2023 elders trip. We will fly out on September 11, 2023 and return on September 15, 2023. We will be staying at the Golden Nugget Hotel and Casino on Freemont Street. Because of space and rooms reserved at the hotel, elders will have to room with another elder or spouse. Unless there is space there will be no single rooms. If you would like to room with a specific person please let Cheryl Miller or Danielle Folz know when you sign up.

The refundable deposit of \$100.00 is due by June 20, 2023 and paid in the accounting department at the tribe. We began accepting deposits on May 22, 2023. After 90 people sign up, we will put names on a waitlist. No partial payments will be accepted.

As a reminder here is the criteria for deposits, spouses under 55 and paid caregivers:

- Elder Spouses aged 55 years and older: are eligible to participate in trips for free. They must pay the required deposit, which will be returned to them during the trip. However, they will not be eligible for a meal stipend.
- Elder Tribal Spouses: who have been married for at least 10 years may attend without their Tribal member spouse, if space and budget allow.
- Non-Elder Spouses: Non-Elder spouses will be responsible for paying half the cost of the trip, not including meals. The funds must be paid by the deposit deadline prior to the trip. They will not be eligible for a meal stipend and the payment is non-refundable.

- Elder Caregivers: Only Elders who require a daily caregiver are eligible to have them accompany the Elder on the trip. Caregivers are defined as those who are being paid to care for an Elder, such as a Chore Service worker. The caregivers will be required to pay a non-refundable deposit towards the cost of the trip. They will not be eligible for meal stipends. All caregivers must sign a contract prior to the trip acknowledging their caregiving responsibilities and agreeing that if they do not fulfill the duties, they may be required to re-pay the Program for the cost of the trip. Because space is limited on the trips, Elders requiring a caregiver may be limited. If the staff believe an Elder may be too fragile to participate in the trip, they may be asked to provide a caregiver or participate in a more appropriate, shorter trip.
- Elder Deposits: A deposit is required to secure a reservation. The deposit will be returned to the elder during the trip. If an elder reserves a slot and does not go on the trip the deposit will not be usually returned unless there was a severe illness or family emergency. If an elder forfeits a deposit (not due to illness or family emergency) for a reservation and the Tribe had to pay for the reservation the elder will only be considered for the wait list on future trips.
